PRIVACY POLICY

The privacy, integrity, and security of your personal information is paramount to us.

This privacy statement contains important information you should know regarding what information is obtained from you while visiting the [Funky Fitness](#) web site and what we do with that information.

For each visitor to our Web page, our Web server automatically recognises the IP address of the visitor and stores this information in our database. This information is primarily used and stored for security and fraud protection purposes.

We collect the e-mail addresses of those who communicate with us via e-mail, aggregate information on what pages visitors access or visit, user-specific information on what pages visitors access or visit, information volunteered by the visitor (such as survey information and/or site registrations), name and address, telephone number, fax number, and payment details/information.

The information we collect is used to

- Improve the content and usability of our Web Site,
- Notify consumers about updates to our Web Site,
- Notify customers regarding changes to their order status, issues concerning order processing, payments processed/declined, refunds issued, cancellations made, changes to order details made, marketing, surveys, and information gathering via all means available.

However, this information will not be shared with commercial organizations, individuals and other entities not under the control or direction of Funky.Fitness for the purposes of marketing and solicitation without the express permission of the customer.

Where assistance is engaged with external organisations to help and assist with in-house marketing campaigns and other forms of advertising, such work will not be engaged without a legally binding agreement precluding the use and distribution of customer information. However, information about you will be disclosed to government authorities/bodies only when legally required to do so, during fraud investigations by State or Federal police and/or government bodies, to verify or enforce compliance with the policies governing our Web Site and applicable laws or to protect against misuse or unauthorised use of our Web Site, to a successor entity in connection with a corporate merger, consolidation, sale of assets or other corporate change respecting the Web Site.

Cookies

With respect to cookies, our web site uses cookies to store visitors preferences, record session information such as items that have been add to the shopping cart, as part of the proper functioning of the web site and to help us to improve our service when visitors return to the Web Site. These cookies are vital for the smooth operation of the Web Site.

Contact Information

Your e-mail addresses are never made available to other organisations. Funky.Fitness will never make customer email lists available to commercial organisations for profit or favour. The customer's privacy is of paramount concern and such information will never be released.
